Todd Mortag - Board Chair, called the Board of Trustees meeting to order at 6:01. Mr. Mortag asked for public comment on **non**-agenda items.

Jodie Campbell - Town of Cascade is proposing changes to water rates. Cascade schools now pays \$35 x 15 plus 2000 gallons for each base. \$535 30,000 gallons. Drop base rate to \$30 and don't give additional gallons of water. Public meeting tomorrow night.

#### **New Business**

- A. Testing 'Opt-Out' Charlie Hawn moved, seconded by Rick Cummings to approve upholding Mr. Barnes decision to follow state statute requiring all students to participate in testing, specifically MAP testing. Jodie Campbell passed out information on US Code 1232h allowing parents to "Opt Out" of educational activities. Ms. Kellogg reiterated that assessments can be used to identify exact skills that each student needs. Brooke Marko asked if we follow guidelines of board, state, or US. Mr. Mortag said we need to draw a line in the sand so guidance is provided for administration and everyone can move forward. Mrs. O'Brien asked about state mandated tests versus optional tests, why can't a there be an option available for optional testing programs. Mrs. Schwindt states that benefits of MAP testing helps eliminate some of the steps in preparing differentiated instruction, can compare our teachers/students to peers nationwide. Mrs. Hastings uses data on a daily basis and sees value of data derived from testing. No one is being harmed by participation, benefits to each child. Mr. Cummings pointed out that US Code was misread, pertaining to which "C" is being referenced in regards to opting out. Mr. Purdy asked for clarification on whether conversation has been had with teacher and can the teacher make assessments without data from test. Mrs. O'Brien stated that MAP should be called an assessment test, not an instructional process. Mr. Mortag states that when you start allowing people to opt out of any given activity, you start opening up a can of worms. Passed Unanimously
